FALL HAS ARRIVED!

As the summer ends, Canadians celebrate Labour Day. This marks the unofficial end of summer (the real end comes on September 22):

LABOUR DAY:

Since the 1880's, Labour Day in Canada has been celebrated on the first Monday in September. In De-

cember, 1872, a parade was held in support of the Toronto Typographical Union's strike for a 58-hour work week.

The following year (1873), the government passed the Trade Union Act. After that, unions began seeking a 54-hour work week. On July 23, 1894, Labour Day was made an official holiday in Canada.

Labour Day is usually celebrated by parades and picnics, final trips to the family cottage. As people go back to school and work after Labour Day, it is considered the unofficial end of summer. This year, Labour Day falls on September 2.


AUTUMN EQUINOX:

This year, on September 22, we will experience the autumn (fall) equinox in the northern hemisphere (half of the world). On the equinox, the sun rises directly in the east and sets directly in the west. The day and night are roughly equal in length. In Latin, equinox means "equal night". Even before the equinox, the days appear to be getting shorter, with darkness coming earlier. Al-

so, it is beginning to get a bit cooler.

In September, there are also several Jewish holidays, including Rosh Hashana and Yom Kippur.




CHANGING THE CLOCKS

At 2 a.m. on November 3, daylight saving time (DST) will end. That means that we will set our clocks back one hour. On March 10 this year, we put our clocks ahead one hour in order to "save daylight". By putting our clocks ahead in the spring, many people believe we make better use of the daylight during the summer. Some believe that it leads to fewer traffic accidents, as people can see better later

in the day; children have more time to socialize and it can increase tourism, as there are more outdoor activities. Many people also believe that daylight saving time leads to reduced energy use, as there is less need for artificial lights. However, not all research shows energy savings.

In 2007, daylight saving time was increased in Canada and the United States. The new start date became the second Sunday in March and the new end date the first Sunday in November.

To remember which way to move your clock at which time, think "in spring, spring (jump) forward, in fall, fall back". The time change is always done on the weekend, so if you forget, you are not late for work or school!



LANGUAGE LEVELS FOR CITIZENSHIP

Starting in November, 2012, all applicants for citizenship between the ages of 18 and 54 must prove that their English or French is at Canadian Language Benchmark (CLB) 4/Niveau de competence linguistique canadien (NCLC) 4.

Citizenship and Immigration Canada (CIC) will accept the following forms of proof:

- Third-party test results that you already sent to CIC or Ministere de l'Immigration et Communatues culturelles Quebec (MICC) for a previous application as a Federal or Quebec-selected skilled worker or Canadian Experience Class
- CELPIP General (Canadian English Language Proficiency Index Program general test)
- CELPIP General (LS) a two skill (listening and speaking) version of the CELPIP general test
- IELTS General training (International English Language Testing System)
- TEF Test d'Evaluation de Français -in French only
- TEFAQ Test d'Evaluation de Français adapte au Quebec (in French only or TEF epreuves orales- a 2 skill (listening and speaking) version of TEF
- Proof of completion of a secondary or post-secondary education program in French or English, in Canada or abroad, such as a transcript, diploma or certificate from a high school or a transcript, diploma, certificate or degree from a college or university. A single course does not meet the requirement
- Proof of achieving CLB/NCLC 4 in speaking and listening through a Language Instruction for Newcomers to Canada (LINC)/Cours de langue pour les immigrants au Canada (CLIC) course. Applicants who successfully complete a course (LINC/CLIC) after November, 2012 should submit a copy of the certificate issued to them
- Proof of achieving CLB/NCLC 4 in speaking and listening issued by a provincially-funded language training course in Manitoba, British Columbia or Quebec.



Those younger than 18 or older than 54 do not have to supply proof of language ability.

RESULTS OF QLIP SURVEY ON ACCESS TO SERVICES

The Quinte Local Immigration Partnership (QLIP) has developed a survey for newcomers accessing local services in the greater Quinte area. A sample group of newcomers recently completed the survey. Most of those surveyed were Permanent Residents who have lived in the greater Quinte area from 3 to 10 years or more.

The participants came from a range of ages, educational backgrounds and professions. Some families had children and had had contact with the educational system, mostly from kindergarten to grade 12.

For health services, most participants used walk-in clinics, followed by hospital visits, and the Belleville and Quinte West Community Health Centre and Health Units.

Very few had made use of community services such as housing or financial services and few had accessed employment services.



Some mentioned that the lack of transportation between population centres was somewhat of a problem.

survey participants' said:

QUIS EXECUTIVE DIRECTOR MEETS MINISTER OF FINANCE



In August, Orlando Ferro, the QUIS Executive Director, along with other local business and municipal leaders, attended a consultation meeting with **Ontario Finance Minister Charles Sousa**, to provide input on the importance of attracting foreign investment to the Quinte Region, the fast tracking of immigration processing times through the Provincial Nominee Program, and the need to increase the minimum wage to revitalize local economies through consumer spending.

Mr. Ferro took the opportunity to express the need to fund a regional immigration portal to provide job/investment information and programs for youth, as well as

the need to eliminate red tape in government.
